They would be pleased if; the Council would also assist wherever possib le in co-ordinating the efforts of individuals or organisations who wished to promote tree planting in roadwide verges. Proposals must be forwarded to the Divisional Surveyor who would be pleased to discuss the suitability of sites and arrange for formal approval.
